Information is collected in order to record and support your participation in the activities you select. In connection with other activities, such as those described above, we may ask you to provide certain information about yourself by filling out and submitting an online form. It is completely optional for you to engage in these activities. If you elect to engage in these activities, however, we may ask that you provide us personal information, such as your first and last name, mailing address (including ZIP or Postal Code), e-mail address, telephone, credit card, and other personal information. If you do not provide the mandatory data with respect to a particular activity, you will not be able to engage in that activity.

In all cases, we will collect personal identification information from you only if you voluntarily submit such information to us. We will also tell you how we use your information or if we share it with another party. Except as otherwise provided in this policy, we will never intentionally disclose any personal identification information about you as an individual user to any third party without having received your permission.

If you supply us with your contact information you may receive periodic e-mails, mailings or calls from us with information on new products and services, important issues, or upcoming events. If you wish to be removed from any postal, e-mail, phone, or other lists, please let us know by e-mailing us. You can also write us or call us at the contact information above. Please provide us with your exact name, e-mail address, mailing address, and phone. We will be sure your name is removed from the appropriate lists in a timely manner.

When you use our Sites, we or our authorized technology services provider may also collect certain technical and routing information from you to facilitate your use of the Site and its services. We use this information to administer the Site and to understand and measure traffic patterns on the Site so that we know which areas of our sites are favorites of our users, which areas need improvement, and what technologies are being used so that we may continually improve our sites. This information is collected in aggregate form, without identifying you or any user individually. We may use this aggregate, non-identifying statistical data for statistical analysis, marketing, or similar promotional purposes.

This data is often tracked by us or our technology services provider by using “cookies” during your visit. A cookie is a small amount of data that is transferred to your browser by a web server and can only be read by the server that gave it to you. It functions as your identification card and enables us to record your passwords, purchases, and preferences. It cannot be executed as code or deliver viruses. Most browsers are initially set to accept cookies. You can set your browser to notify you when you receive a cookie, giving you the chance to decide whether or not to accept it. (For some web pages that require an authorization, cookies are not optional. Users choosing not to accept cookies will probably not be able to access those pages.)

## **Exceptions To Privacy Policy**

While we are committed to keeping your information secure and private, we have the following exceptions to our privacy policy: We will release specific information about you or your account to comply with any valid legal inquiry or process such as a search warrant, subpoena, statute or court order. We will also release specific information in special cases, such as if there is an attempted breach of the security of the Sites, or a physical or property threat to you or others. We may also transfer user information, including personally identifiable information, in connection with a corporate merger, consolidation, the sale of related assets or corporate division or other fundamental corporate change.

Further, the information you enter when making a purchase or an online donation will be shared with payment processors, financial gateways, and your credit card company to authorize credit card payments. Such information may also be shared with necessary third parties solely for the purpose of carrying out the transactions. Please note that if you give out personal information online through a discussion board or posting site, that information can be collected and used by third parties. Although we strive to protect our users' privacy, we cannot guarantee the security of information you post in these forums. You disclose such information at your own risk.

## **Miscellaneous**

These terms will be governed by and construed in accordance with the laws of the Province of Ontario, Canada, without regard to any principles of conflicts of law. You agree that any action at law or in equity that arises out of or relates to these terms will be subject to mediation in the Province of Ontario. If any of these terms of use are found unlawful, void, or for any reason unenforceable, then that provision will be considered severable from the remaining terms of use, and will not affect the validity and enforceability of the remaining provisions. These terms may be modified only by our posting of changes to these terms of use on our Site.

### **You may wish to consider some from these three paragraphs:**

**When You Register for Our Services.** We receive and store any information you provide to us when registering with our Services such as your name, username, password, country of location, postal/zip code, postal mail address, and email address. Some of our Services may collect your photo, "about" information you provide, links to your social media accounts, and certain other profile information. You may be asked to provide your mobile phone number if you register for a Service which sends you a text message containing information you have requested. If you are a member of a Service through which you may receive a payment, we collect your tax identification and Paypal email address.

**When You Visit Our Websites or Use Our Services.** Even if you do not register with us, whenever you interact with our Services, we may collect the following: IP address, language setting, operating system type, the page(s) you requested, an Identifier for Advertising if you are using an iOS device or an Android ID if you are using an Android device, user agent, geo-location, and time stamp. We collect information about your search and click activity on the Services (for example, when you "favorite" a product featured on or "follow" a brand, designer, or another user on our Services). With your permission, we may have access to your photo album in connection with providing you a Service (i.e. Emoticode). We may collect your user generated content or activity related to your use of certain Services (for example, photos that you take or upload, comments that you provide or workout routines that you create, or URL links). If we start an e-store and you make a purchase through our Services, we may also collect your information as set forth in any Payment Card Information section.

**When You Provide Third Party Account Information.** If you provide or connect your third-party account credentials to an account with a Service, some content and/or information in those accounts may be transmitted into your account with us. For example, when you connect with Facebook, we receive and collect your name, email address, and profile photo.
